Contract Agreement and General Information

On April 14th there will be an Educational Conference and the 27th Wholistic Living Expo will be on April 15th.

We ask that you come as early as possible to be set up by 8:30 am to ensure that you are ready for opening time at 9:00am. Breakdown time is 5:00-6:00 pm.....Upon arrival please go to the reception area to receive your name-tags and location information.

No lit flames are allowed.

2. All vendors and psychic readers are required for the entire length of the day (9:00am-5:00pm). 2 name tags will be provided for each vendor space. You will need a pass for each person working your booth.

3. All vendors and psychic readers must clear their space when doors close at 5:00 pm. Please leave the space as neat and tidy as possible, disposing of all trash and removing all your materials.
